#### 1. INSPECTION OF TREES:-

The interested parties may inspect the planted trees at the premises of PAJL Plants Hoshiarpur and Abohar at any working day between 09.00 a.m. to 05.00 p.m. with the prior approval of concerned Plant Head, as per detail below:-

The entire lot of trees shall be dispose-off "As on where As basis" planted at PAJL Plants premises.

#### 2. <u>EARNEST MONEY & SECURITY</u>:-

2.1 The tenderer / bidder shall deposit earnest money amounting to Rs. 25,000/- (Rupees Twenty Five Thousand only), for each site.

The earnest money shall have to be paid online. Tenders without the requisite earnest money shall be rejected. The earnest money of all unsuccessful Page 2 of 6

tenderers / bidder will be refunded in due course of time without any interest. In case the tenderer / bidder did not deposit the full earnest money mentioned in the tender notice, tenderer / bidder offer shall not be considered.

2.2 Earnest money of successful tenderer / bidder will be converted into security deposit and will be returned after successful completion of the rate contract without any interest.

# 3. CONTRACT FOR UPROOTING, CUTTING & DEBRIS REMOVAL OF TREES:-

The contract will be for a period of 03 month from the date of the award of contract which may be extended further with mutual consent.

**4.** Tenderer / bidder shall abide by the terms and conditions of the tender.

#### 5. PAYMENT TERMS:-

The successful tenderer / bidder shall deposit the entire money for each consignment prior to shifting of uprooted trees, timber, branches and leaves before loading the trucks. In any case no material shall be allowed to leave the premises of PAJL without depositing the value of the dispose-off material.

- **6.** The tenderer/bidder shall offer the rates on per quintal/kg basis for the following:-
  - (a) Timber ...... Rs. ...../- per kg for all varieties.

  - (c) Secondary branches ...... Rs. ....../- per kg for all varieties.
  - (d) Roots upto the ground level ........... Rs. ......../- per kg for all varieties.
  - (e) Leaves ...... Rs. ...../- per kg for all varieties.

The offer rates includes the cutting of trees, uprooting of roots portion of the trees, cutting of main timber, side branches, separation of leaves and cleaning of debris from the site, Ex-factory basis. The transportation charges shall borne by the tenderer / bidder.

- 7. The tenderer / bidder shall arrange own machinery, tools, equipments for cutting and removing & transportation of trees from the premises of PAJL Plants Hoshiarpur and Abohar.
- **8.** If the tenderer / bidder wants to use electricity/water for any machinery to be used that shall be chargeable on per unit basis as per actual consumption.

9. No manpower or equipment shall be provided by the PAJL to the successful tenderer at any stage. The successful tenderer / bidder shall arrange its own transportation / boarding lodging for the manpower to be used for removal of tress from the premises of PAJL.

## 10. ACCEPTANCE OF TENDER AND WITHDRAWALS:-

The final acceptance of the tender is entirely vested with Punjab Agro Juices Limited which reserves the right to accept or reject any or all of the tenders in full or in parts without assigning any reason whatsoever. Punjab Agro Juices Limited may also reject all the tenders for reasons such as change in scope, specification, lack of anticipated financial resources, court orders, calamities or any other unforeseen circumstances. All tenders shall be irrevocable and remain valid for acceptance for a period of 30 (thirty) days from the date of opening of tender(s). After acceptance of the Tender by PAJL, the Successful Tenderer shall have no right to withdraw their tender or claim lower price.

## 11. LETTER OF ACCEPTANCE:-

After acceptance of the tender, a Letter of Acceptance (LOA) will be issued to the Successful Tenderer.

- **12.** The Managing Director of Punjab Agro Juices Limited, Chandigarh will have the discretion to extend the date of receipt and opening of tender.
- **13.** Any change in constitution of the firm shall not absolve any partner of the firm from the liability.

#### 14. <u>DISPATCH PLACE:-</u>

Rates should be quoted FOR PAJL Plants Hoshiarpur & Abohar for entire lot of trees.

#### 15. DISPOSAL PERIOD:-

Within 03 months after issue of release order.

#### 16. TAXES AND DUTIES:-

Should be clearly mentioned in the offered rates schedule or as applicable.

17. The tenderer / bidder shall be responsible for removal-off material within week, after cutting the tress from the premises of PAJL, otherwise PAJL will charge Rs. 2.00/- per kg per month as storage charges maximum upto one month prior to deposit of entire stocks value and the losses, if any, shall be on the part of tenderer / bidder. After leaving the premises of PAJL the stock responsibility shall be on the tenderer / bidder. If the tendere / bidder fail to remove the material from the PAJL premises after one month, PAJL shall have the right to dispose-off the stocks to some other party and losses, if any, shall be recovered from the tenderer / bidder.

## 18. ARBITRATION:-

In case of any dispute arising out of the contract, the matter shall be referred to the Managing Director, Punjab Agro Juices Limited, Chandigarh to arbitrate in the mater, who can arbitrate himself or can appoint anybody to arbitrate in the matter. The said arbitrate proceedings shall be held under the jurisdiction of Chandigarh Court only & as per provision of the Arbitration & Conciliation Act, 1996.
