Term and conditions for RCC FLOOR Reeling at PAJL Plant Abohar

1. <u>Description</u>:- TO COMPLETE THE RCC FLOORING

RCC Flooring on turn-key basis is to be provided at Cold Store in PAJL, ABOHAR Plant, approximate area 15000 Square Feet.

2. Scope of work: To clear the damaged floor from the Cold Room, clearing of debris / and reeling of RCC floor.

3. Specifications:-

- (i) Base flooring needs to be repaired / re-laid as per actual site requirement.
- (ii) RCC flooring thickness 03 inch as per BIS Specifications with suitable thickness for industrial use/forklift movement with proper grouting, filing material and with proper grinding is to be laid.
- (iii) The ratio of cement, crusher and fine sand should be 1:2:04

4. General Term and Conditions:-

- (i) The rates should be quoted in Rs. _____ per square feet basis for completing the job. (clearing of damaged floor from the floor, clearing of debris / and reeling of RCC floor (Including re-fixing of RCC Tiles & flooring)
